PCC Community Wellness Center (PCC)

PCC is a Federally Qualified Health Center (FQHC) with 11 locations in Chicago, Berwyn, Melrose Park and Oak Park. PCC offers outpatient primary care, inpatient obstetrics, and adult family medicine services. Using a family medicine model, PCC provides a full spectrum of services throughout the life cycle. In addition to standard medical and preventative care, this comprehensive approach includes mental health care, substance abuse treatment, oral health care, and support services.

Why PCC?

At PCC you can work in a team-based care setting as a team nurse, maternal child health (MCH) nurse, or a team lead nurse. Team-based care includes nurses, medical assistants, patient care representatives, and care coordinators that work to the top of their training to best care for patients.

Work with a team that provides these services:

- Integrated behavioral health
 - Behavioral health consultants at each site
 - Psychiatric advanced practice nurses serving all sites
- Financial counseling
- Dental services
- Sports Medicine and Ultrasound
- Health education and urban farm
- Birth Center at PCC, only freestanding birth center in Chicagoland

Nurse duties may include:

- Vitals and preparation for exams
- Laboratory and diagnostic tests
- 1 month well-child visits
- Medication injections
- Screening/treatment for UTIs, sore throats, common colds
- STD testing and treatment
- · Newborn weight checks
- TB Screenings
- Pediatric ER follow-up
- Wound care
- Stitch removal
- Pregnancy testing
- Home visits and follow-up
- Individual health education

Your Benefits at PCC

Group Benefits

You can select any combination of the medical, dental and/or vision plans.

Benefits are effective the 1st of the month following 30 days of employment.

Medical: Blue Cross Blue Shield of Illinois — 4 plan options (2 PPO and 2 HMO)

Dental: Humana — 1 plan option

Vision: Humana — 1 plan option

Group Term Life, AD&D, and Long Term Disability: Provided by PCC through UNUM at twice the base compensation. The maximum benefit is \$200,000 at no

cost to eligible employees.

Paid Time Off

Vacation: 15 days

Sick: 12 days

Personal: 3 days

Holidays: 7 days

Voluntary Benefits

Voluntary Life Insurance and AD&D: Through UNUM you can purchase up to three times the base compensation for yourself or a maximum of \$150,000 of life insurance (whichever is less). **Voluntary Short Term Disability:** Available for purchase through MetLife on a post-tax basis.

Eligibility Requirements

Full-Time Employees (0.75—1.0 FTE) are eligible for vacation, holidays, sick and personal time, medical insurance, dental insurance, vision insurance, group term life insurance, group long term disability insurance, voluntary life insurance, and voluntary short term disability.

Part-Time Employees (0.50—0.70 FTE) are eligible for vacation, holidays, sick and personal time, medical insurance, dental insurance and vision insurance.

Continuing Education Unit (CEU)

8 Hours annually Full-time: \$300 Part-time: \$150

NURSE Corps Loan Repayment Program

Licensed registered nurses, advanced practice nurses, and nurse faculty can have 60% of their nursing education debt paid, in exchange for a two-year commitment at a Critical Shortage Facility like PCC.
